
**RESOLUTION AND ORDER**

On September 22, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("September 22 Resolution") through which, among others, ordered GENERA PR, LLC ("Genera") to file, within 30 days of issuing the September 22 Resolution, a detailed Corrective Action Plan outlining the steps it intends to take to align its labor costs with the approved budgets.<sup>1</sup>

On October 19, 2023, Genera filed a document titled *Motion for Brief Extension of Time to Comply with Order to Submit Corrective Action Plan* ("October 19 Request"), in which Genera alleges that it needs additional time to file the Corrective Action Plan to comply with the September 22 Resolution. Genera requests until **October 30, 2023**, to file the Corrective Action Plan.<sup>2</sup>

Upon review, the Energy Bureau **GRANTS** Genera until **October 30, 2023**, to file the Correction Action Plan as required in the September 22 Resolution.


