SUBJECT: Resolution and Order to *Motion for Extension of Time to Comply with the October 26th Order*.

RESOLUTION AND ORDER

On October 26, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued an Order ("October 26 Order") through which, among others, ordered GENERA PR LLC ("Genera") to file a detailed response to the ROI set forth in Attachment A of the October 26 Resolution with the deadline set for November 2, 2023.¹

On November 2, 2023, Genera filed a document titled *Motion for Extension of Time to Comply with the October 26th Order* ("November 2 Request"), in which Genera alleges that it needs more time in order to provide a thoroughly and comprehensive response to the ROI included in the October 26 Order. Genera requests until **November 9, 2023**, to respond to the ROI.²

Upon review, the Energy Bureau **GRANTS** Genera until **November 9, 2023**, to respond to the ROI included in the October 26 Order.

The Energy Bureau **WARNS** Genera that filing an extension request the same day that it was due is not acceptable. Any request for extension **MUST** be requested with enough time before the expiration date in order for the Energy Bureau to analyze such request. The deadlines ordered by the Energy Bureau have a procedural and analytical purpose and **MUST** be respected. The Energy Bureau shall not impose a fine at this moment, but **ALERTS** Genera to refrain from this practice in any orders issued by the Energy Bureau.






