SUBJECT: Resolution and Order to *Motion Requesting Extension of Time to Comply with Resolution and Order dated September 22, 2023.*

RESOLUTION AND ORDER

On September 22, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("September 22 Order") through which, among others, ordered GENERA PR, LLC ("Genera") to (i) submit, within 30 days of issuing the September 22 Resolution, with the deadline being October 22, 2023, a detailed Corrective Action Plan outlining the steps Genera intends to take to align its labor costs with the approved budgets, including a timeline for each action, responsible parties, and expected outcomes; (ii) submit a detailed report on potential labor reimbursements from Federally Funded Projects and their allocation to supplement the labor budget, with a deadline being, November 6, 2023.¹

On November 6, 2023, Genera filed a document titled *Motion Requesting Extension of Time to Comply with Resolution and Order dated September 22, 2023.* ("November 6 Request") in which Genera, in good faith, request an extension to enable (i) a brief, one-day extension of time to submit the pending information pursuant to Item 5 of the Corrective Action Plan and (ii) a one week extension, until November 13, 2023, to submit the Federally Funded Projects Labor Reimbursement Projections report. Genera requests until **November 13, 2023**, to comply with the September 22 Resolution.²

Upon review, the Energy Bureau **GRANTS** Genera a one-day extension to comply with the filing of the Corrective Action Plan and until **November 13, 2023**, to comply with the submission of the Federally Funded Projects Labor Reimbursement Projects Report.




