**MOTION IN COMPLIANCE WITH RESOLUTION AND ORDER**

**TO THE PUERTO RICO PUBLIC SERVICE REGULATORY BOARD:**

**COMES NOW** the Puerto Rico Electric Power Authority ("PREPA") through its undersigned legal counsels and respectfully informs and requests as follows:

1. On October 24<sup>th</sup>, 2023, the Puerto Rico Public Service Regulatory Board ("Energy Bureau") entered a *Resolution and Order* whereby it ordered PREPA, *inter alia*, to file its response to the first Requirement of Information, PREB-PREPA-01-01 ("First ROI"), on or before November 3<sup>rd</sup>, 2023 ("October 24 Resolution").

2. On November 3<sup>rd</sup>, 2023, PREPA filed its *Notice of Appearance and Request for Extension of Time* ("Motion for Extension of Time"), where it requested an extension of time until Friday, November 10<sup>th</sup>, 2023, to comply with the October 24 Resolution.

3. On November 8<sup>th</sup>, 2023, the Energy Bureau entered a *Resolution and Order* whereby it granted the Motion for Extension of Time.

4. In compliance with the October 24 Resolution, PREPA hereby submits its response to the First ROI:

**PREB-PREPA-01-01:** Confirm that PREPA is prepared to provide the information required to satisfy LUMA's needs for each Schedule where PREPA is identified in Column F ("LUMA Dependency on Other Entities").

**RESPONSE TO PREB-PREPA-01-01:** PREPA hereby confirms that it is prepared to provide the necessary financial and other available information, including support for PREPA's proposed FY2025 budgets for Base Rates Revenue Requirement, historical financial reports and operational statistics, capital lease information for PREPA controlled assets/liabilities, and written testimony, for rate filing schedules and other Energy Bureau requirements identified by LUMA as requiring PREPA's input in Appendix A to the Rate Review – Phase 1 Report.

**WHEREFORE,** PREPA respectfully requests the Energy Bureau to take **NOTICE** of the foregoing and deem the October 24 Resolution as complied with by PREPA.
