
RESOLUTION AND ORDER

On November 29, 2023, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("November 29 Order") through which, among others, ordered LUMA¹ to file, by December 8, 2023, six requests regarding the TPP² and the Three-Year Extension Plan.³


On December 7, 2023, LUMA filed a document titled *Request for Extension to Comply with the Order for LUMA to Provide Information under the Resolution and Order of November 29, 2023*. ("December 7 Request"), in which LUMA respectfully requests to extend the deadline to present the updated TPP required in the November 29 Resolution and Order as well as comply with all other requirements of such order until December 20, 2023.⁴

Upon review, the Energy Bureau **GRANTS** LUMA until **December 20, 2023**, to submit the information required of LUMA under the November 29 Order.


