**MOTION TO REQUEST AN EXTENSION OF TIME TO COMPLY WITH NOVEMBER 29TH
ORDER**

TO THE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority ("PREPA"), through its counsel of record, and respectfully submits and prays as follows:

1. On August 26th, 2022, PREPA executed a power purchase and operating agreement ("PPOA") for the Salinas Solar Project, and an Energy Storage Services Agreement ("ESSA") for the Salinas Battery Project.
2. On July 10th, 2023, PREPA executed the fourth amendment to the PPOA and ESSA to modify, among other things, the Conditions Subsequent Deadline, as defined in the amendment, to November 30th, 2023.
3. On November 28th, 2023, PREPA filed the *Urgent Motion to Submit the Fifth Amendment to the PPOA and ESSA* for the Energy Bureau of the Puerto Rico Public Service Regulatory Board's ("Energy Bureau") review and approval.
4. On November 29th, 2023, the Energy Bureau issued a *Resolution and Order* whereby it, among other things, approved the fifth amendment to the PPOA and ESSA and ordered PREPA to assess any potential reduction in the costs associated with the project's interconnection.

5. PREPA informs that it is still working on the assessment and needs to corroborate some information with the parties involved to conclude the evaluation. Therefore, PREPA respectfully requests the PREB five (5) business days to comply with the November 29th Order.

WHEREFORE, PREPA respectfully requests the Energy Bureau to take **NOTICE** of the foregoing and **GRANT** the requested extension.
