3. The undersigned attorneys are currently reviewing the docket in the above-captioned case, including the most recent Resolutions and Orders. In order to responsibly complete this endeavor and determine PREPA's responsibilities in this case, PREPA respectfully requests an extension of ten (10) business days, until February 12th, 2024, to comply with any *Resolution and Order* that requires an action by PREPA in this case.
