**MOTION FOR EXTENSION OF TIME TO FILE MEMORANDUM OF LAW IN
SUPPORT OF CONFIDENTIAL TREATMENT OF EXHIBIT 1 FILED BY LUMA ON
FEBRUARY 12, 2024**

COME NOW LUMA Energy, LLC and LUMA Energy ServCo, LLC (jointly “LUMA Energy”), through the undersigned counsel, and respectfully state and request the following:

1. On February 12, 2024, LUMA filed with Puerto Rico Energy Bureau of the Public Service Regulatory Board (“Energy Bureau”) a *Motion To Submit Information in Compliance with Resolution and Order of February 5, 2023 and Request for Confidential Treatment* (“February 12th Motion”) in which it submitted a confidential Exhibit 1 containing information requested by the Energy Bureau by Resolution and Order of February 5, 2024. In the February 12th Motion, LUMA requested the Energy Bureau to receive and maintain such Exhibit 1 (“February 12th Exhibit 1”) under seal of confidentiality and informed that it would be submitting the supporting Memorandum of Law within the next ten (10) days. *See* February 12th Motion on page 4.

2. The undersigned are in the process of preparing the mentioned Memorandum of Law, but despite the undersigned’s best efforts, additional time is needed to complete this memorandum. It is anticipated that this effort may be completed within the next three (3) days.

WHEREFORE, it is respectfully requested that this honorable Energy Bureau grant an extension of three (3) days to file the Memorandum of Law in support of the request for confidential treatment of Exhibit 1 to the *Motion To Submit Information in Compliance with Resolution and Order of February 5, 2023 and Request for Confidential Treatment* filed by LUMA on February 12, 2024.
