SUBJECT: Resolution about Motion for Partial Reconsideration of Final Resolution and Order of January 22, 2024 and Request for Further Processes, filed by LUMA Energy, LLC and LUMA Energy ServCo, LLC.

RESOLUTION

On January 22, 2024 the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order in this regulatory proceeding ("January 22 Resolution"). On February 12, 2024, LUMA Energy, LLC and LUMA Energy ServCo, LLC (jointly referred to as "LUMA") filed before the Energy Breau a document titled *Motion for Partial Reconsideration of Final Resolution and Order of January 22, 2024 and Request for Further Processes* ("February 12 Motion").

The Energy Bureau acknowledges the February 12 Motion and inform that it will address this matter in due course. However, it is important to clarify that this process does not constitute an adjudicative proceeding. The Energy Bureau's approach in this case will be to thoroughly review and consider the February 12 Motion within the framework of its regulatory and policy mandates. This review aims to ensure comprehensive understanding and fair consideration. However, it should not be interpreted as a formal legal adjudication as defined in Chapter III of Act 38-2017.¹
