RESOLUTION AND ORDER

On January 26, 2024, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued its Final Resolution and Order on Performance Targets for LUMA Energy, LLC¹ ("Final Resolution").

On February 15, 2024, LUMA filed a document titled Luma's Motion for Reconsideration of Final Resolution and Order in which LUMA requested that the Energy Bureau reconsider the Final Resolution ("LUMA's Reconsideration Request").

On February 15, 2024, LECO² filed a document titled Local Environmental and Civic Organizations' Motion for Reconsideration of the Final Resolution and Order on Performance Targets for Luma Energy, LLC and Luma Energy Servco, LLC requesting that the Energy Bureau reconsider the Final Resolution ("LECO's Reconsideration Request").

On February 22, 2024, LUMA filed a document titled Luma's Notice of Intent to Respond to the Local Environmental and Civic Organizations' Motion for Reconsideration of Final Resolution and Order on Performance Targets for Luma Energy LLC And Energy Servco, LLC in which LUMA informed that if the Energy Bureau determines that it will accept and consider LECO's Motion for Reconsideration on the merits, LUMA intends to respond to and oppose LECO's Motion for Reconsideration.³ LUMA requested leave to file a response and opposition to LECO's Motion for Reconsideration, within twenty (20) days after the Energy Bureau issues a determination that it will accept and consider on the merits LECO's Motion for Reconsideration.

The Energy Bureau TAKES NOTICE of LUMA's Reconsideration Request, LECO's Reconsideration Request and of LUMA's Notice of Intent. The Energy Bureau **DETERMINES** that it accepts and will evaluate the merits of LUMA's Reconsideration Request, LECO's Reconsideration Request in accordance with the provisions of Section 3.15 of Act 38-2017, known as the Puerto Rico Uniform Administrative Procedure Act, as amended and Section 11.01 of Regulation 8543, Regulation on Adjudicative, Notice of Noncompliance, Rate Review and Investigation Procedures. The Energy Bureau GRANTS LUMA twenty (20) days from the notification of this Resolution and Order to file its Response to LECO's Reconsideration Request and GRANTS LECO twenty (20) days from the notification of this Resolution and Order to file its response to LUMA's Reconsideration Request.
