SUBJECT: Resolution and Order in response to *Motion in Compliance with the March 15th Resolution and Order,* filed by PREPA.

RESOLUTION AND ORDER

On March 15, 2024, the Puerto Rico Electric Power Authority ("PREPA") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Urgent Motion to Submit the Execution Version of the Asset Purchase Agreement* ("March 15 Request"),¹ in which PREPA requested that the Energy Bureau evaluate and approve the Proposed Asset Purchase Agreement and designate and treat as confidential Exhibits A, B and C included with the March 15 Request.

On March 15, 2024, the Energy Bureau issued a Resolution and Order ("March 15 Order"), in which, about this Resolution and Order, granted confidential treatment to Exhibit A, B and C of the March 15 Order and ORDERED PREPA to file a redacted version of such Exhibits. The purpose of ordering a redacted version is for the public to have access of such Exhibits.

On March 20, 2024, PREPA filed a document titled *Motion in Compliance with the March 15th Resolution and Order* ("March 20 Motion"), in which PREPA informs that Exhibits A, B, and C of the March 15 Request ("March 15 Exhibits") no longer requires confidential treatment since the approval process was completed and the contract that referenced the March 15 Exhibits was executed and submitted to the Comptroller of Puerto Rico's Office and PREPA withdraws its request for confidential treatment for the March 15 Exhibits.²

The Energy Bureau **TAKES NOTICE** of PREPA's withdrawal of confidential treatment of the March 15 Exhibits.

The Energy Bureau **ALLOWS** PREPA's request of withdrawal of confidential treatment to the March 15 Exhibits and **ORDERS** the Clerk's Office to remove the confidential treatment given to the March 15 Exhibits and file the March 15 Exhibits as public documents.
