## MOTION TO SUBMIT FINAL DRAFT OF GENERA'S EMERGENCY RESPONSE PLAN IN COMPLIANCE WITH THE RESOLUTION AND ORDER DATED APRIL 2, 2024

#### TO THE HONORABLE PUERTO RICO ENERGY BUREAU:

**COMES** NOW GENERA PR LLC ("Genera"), as agent of the Puerto Rico Electric Power Authority ("PREPA"), through its counsels of record, and respectfully submits and prays as follows:

- 1. On August 18, 2023, Genera submitted to the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Motion to Submit Revised Emergency Response Plan in Compliance with Resolution and Order dated June 30, 2023*, through which it submitted its revised Emergency Response Plan ("ERP").
- 2. On March 4, 2024, the Energy Bureau issued a Resolution and Order titled *Filing* of Emergency Response Plans ("ERP") LUMA, Genera, PREPA, EcoEléctrica, AES and Revision Interactive Process ("March 4<sup>th</sup> Resolution") through which it established the annual ERP

revision interactive process for the 2024 evaluation cycle, as detailed in Attachment A contained therein.

- 3. On April 2, 2024, following several procedural events, the Energy Bureau issued a Resolution and Order titled *Rescheduling of Technical Conference* ("April 2<sup>nd</sup> Resolution"), through which it granted certain PREPA's and LUMA's requests for a continuance and rescheduled the virtual Technical Conference for April 25, 2024, at 10:00 a.m. Additionally, through the April 2<sup>nd</sup> Resolution, the Energy Bureau amended the schedule in Attachment A of the March 4<sup>th</sup> Resolution, as included in the April 2<sup>nd</sup> Resolution. The revised Attachment A required Genera to file the final draft of the ERP for review by the Energy Bureau on May 9, 2024.
- 4. On April 25, 2024, Genera participated in the technical conference convened by the Energy Bureau to discuss the respective ERP filings from PREPA, LUMA, and Genera (the "April 25<sup>th</sup> Technical Conference"). During the April 25<sup>th</sup> Conference, the Energy Bureau issued critical bench orders and advanced a series of significant requests and amendments aimed at the comprehensive updating of the ERPs.
- 5. In compliance with the April 2<sup>nd</sup> Resolution and in alignment with the directives issued during the April 25<sup>th</sup> Technical Conference, Genera hereby submits the final draft ERP for thorough review by the Energy Bureau, designated as Exhibit A to this motion.
- 6. Additionally, Genera respectfully informs the Energy Bureau that the final draft ERP, submitted as Exhibit A to this motion, is filed under a seal of confidentiality due to its inclusion of Critical Energy Infrastructure Information. Genera also respectfully requests that the Energy Bureau maintain Exhibit A under this seal of confidentiality, in accordance with the Energy Bureau's Policy on Management of Confidential Information, CEPR-MI-2016-0009, issued on

August 31, 2016, and partially amended on September 16, 2016. In line with this policy, Genera will submit a Memorandum of Law supporting this request within the next ten (10) days.

**WHEREFORE**, Genera respectfully requests that the Energy Bureau **take notice** of the above for all purposes and **deem** Genera to be in compliance with the April 2<sup>nd</sup> Resolution.
