RESOLUTION NUNC PRO TUNC


On June 12, 2024, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("June 12 Resolution") through which it included a *Procedural Schedule* in Section IV.

The *Procedural Schedule* includes a Virtual Technical Conference to be held on June 20, 2024, and a Virtual Public Hearing to be held on June 25, 2024. The *Procedural Schedule* didn't include the time of commencement of both hearings.
