**MOTION FOR EXTENSION OF TIME TO COMPLY WITH
THE JUNE 14TH RESOLUTION**

TO THE HONORABLE ENERGY BUREAU,

COMES NOW the Puerto Rico Electric Power Authority ("PREPA") through its undersigned legal representation and, very respectfully, informs and requests as follows:

1. On June 14th, 2024, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a *Resolution and Order* ("June 14th Order") whereby it ordered PREPA to submit a response in five (5) days to a Request for Information with regards to the signed Power Purchase Operating Agreements ("PPOAs") and Energy Storage Services Agreements ("ESSAs").

2. Despite its diligent efforts, PREPA has been unable to fully complete the responses. Although PREPA has collected most of the documentation requested by the Energy Bureau, some information needed to be obtained directly from the Service Providers to ensure accurate information is provided to the Energy Bureau.

3. In light of the foregoing, PREPA hereby respectfully requests an extension of twenty (20) days **until July 10th, 2024**, to comply with the June 14th Order.

WHEREFORE, PREPA respectfully requests the Energy Bureau to **GRANT** the requested extension of **twenty (20) days, until July 10th, 2024**, to comply with the June 14th Order.
