**MOTION TO REQUEST EXTENSION TO SUBMIT PREPA'S FEDERAL FUNDING AND GRID
MODERNIZATION IMPLEMENTATION REPORT FOR JUNE 2024**

COMES NOW the Puerto Rico Electric Power Authority ("PREPA"), through its counsel of record, and respectfully submits and requests as follows:

1. On June 25, 2023, the Puerto Rico Energy Bureau ("PREB") issued a Resolution and Order modifying and, as such, approving the Consolidated Annual Budgets for Fiscal Year 2024 (hereinafter, the "June 25th Resolution").
2. In addition, the PREB directed PREPA to present the Implementation of the Grid Modernization Plan on a bi-monthly basis (hereinafter, the "Grid Modernization Report"). Per the June 25th Resolution, the Grid Modernization Report shall include a comprehensive overview of the primary investment areas and projects being considered by PREPA to ensure the provision of dependable and resilient power, along with the current progress of project milestones.
3. PREPA was also ordered to submit monthly reports with the PREB detailing federal funding activity during the quarter for hydro facilities, including progress on submitting and advancing PWs and Scopes of Work (SOWs), by

hydro/dam site, the cumulative amount of federal funding applied for, the incremental amount of federal funding applied for in the reporting quarter and both the cumulative and monthly amount of federal funding received.

4. On November 13, 2023, the PREB issued a Resolution and Order to authorize, among other things, a monthly cadence for the Grid Modernization Implementation Report.
5. PREPA is in the process of finalizing the Grid Modernization Implementation Report. Notwithstanding, PREPA respectfully requests the Energy Bureau for an extension until July 8th, 2024, to finalize and submit the report. This request is made in good faith, with no intention of delaying the PREB's evaluation of the Grid Modernization Implementation Report.

WHEREFORE, PREPA respectfully requests: (a) the Energy Bureau to take **NOTICE** of the information provided, and (b) GRANT until July 8th, 2024, to submit the Grid Modernization Implementation Report.
