## **RESOLUTION AND ORDER**

On September 11, 2024, LUMA submitted a Motion Requesting Technical Conference ("September 11 Motion") with a request for an in-person Confidential Technical Conference between September 17 and September 20, 2024. LUMA indicated that the purpose of the requested conference would be "to offer detailed insight into the status of the 2024 IRP and the complexities and challenges encountered".1 LUMA asserts in the September 11 Motion that the complexities and challenges, and unforeseen modeling delays renders the November 29, 2024 filing date "impossible to comply with".2

The Puerto Rico Energy Bureau **GRANTS** the request for a Confidential Technical Conference and schedules it for September 18, 2014 at 10:00 a.m. For those parties unable to attend in person, a virtual conference link will be provided.

Nothing in this Resolution and Order should be interpreted to indicate that the filing date of November 29, 2024 is or may be modified. The Energy Bureau EXPECTS LUMA and its consultant to continue to work towards filing portions of the IRP on that date, as indicated in the August 20, 2024 Resolution and Order. The Energy Bureau will determine LUMA's September 11 Motion request after the September 18, 2024 conference.
