**RESOLUTION AND ORDER**

On November 12, 2024, LUMA Energy, LLC and LUMA Energy ServCo, LLC (referred to jointly as "LUMA") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Motion to Submit Information on Three Finalized Standard Offer Agreements in Compliance with Resolution and Order of November 1, 2024, and Request for Extension to Submit Finalized Fourth Agreement, Clarification on Next Steps, and Confidential Treatment* ("November 12 Motion"). LUMA submitted finalized versions of three (3) Standard Offer Agreements ("SO Agreements") with Phase 1 *Accelerated Storage Addition Program* ("ASAP") participants and evidence of submittal of these agreements to PREPA. LUMA requested that the Energy Bureau maintain Exhibits 1 and 2 of the November 12 Motion confidential and indicated that it would submit a Memorandum of Law supporting its request for confidential treatment, within ten (10) days.

On November 14, 2024, the Energy Bureau issued a Resolution and Order in which it determined to keep Exhibits 1 and 2 to the November 12 Motion confidential, noting that LUMA would submit a Memorandum of Law supporting its confidentiality request, within ten (10) days. The Energy Bureau highlighted it would issue its final decision about the confidentiality request in a separate resolution.

On November 25, 2024, LUMA requested a three (3) day extension to file the Memorandum of Law supporting the request for confidentiality.




On December 2, 2024, LUMA filed a document titled *Motion for Additional Extension of Time to File Memorandum of Law in Support of Request for Confidential Treatment of Exhibits 1 and 2 Submitted on November 12, 2024* ("December 2 Motion"), whereby it requested three (3) additional days to file the referenced memorandum.

The Energy Bureau **GRANTS** the requested extension and **WARNS** LUMA that non-compliance with this Resolution and Order will result in the imposition of fines, in accordance with Art. 6.36 of Act 57-2014.<sup>1</sup>
