**MOTION FOR EXTENSION OF TIME TO FILE MEMORANDUM OF LAW  
IN SUPPORT OF CONFIDENTIAL TREATMENT OF EXHIBIT 1  
SUBMITTED ON MAY 2, 2024**

**TO THE HONORABLE ENERGY BUREAU:**

**COME NOW LUMA Energy ServCo, LLC and LUMA Energy, LLC** (collectively "LUMA") through their undersigned legal counsel and respectfully submit and request the following:

On May 2, 2024, LUMA filed a *Motion in Compliance with Resolution and Order from March 19, 2024, and Request for Confidential Treatment* ("May 2<sup>nd</sup> Motion") and requested the confidential treatment of *Exhibit 1* to the May 2<sup>nd</sup> Motion. In the May 2<sup>nd</sup> Motion, LUMA stated that pursuant the Energy Bureau's Policy on Management of Confidential Information, CEPR-MI-2016-0009, issued on August 31, 2016, and partially amended on September 16, 2016, it would be submitting within the next ten (10) days a Memorandum of Law in support of the request for confidential treatment of *Exhibit 1*.

The undersigned is in the process of preparing the mentioned Memorandum of Law, but despite the undersigned's best efforts and given the extensive amount of documents comprising Exhibit 1, additional time is needed to complete this memorandum. It is anticipated that this effort

may be completed within the next five (5) days. Taking into account that the documents in Exhibit 1 are to be maintained confidential during and until the end of the referenced investigation (*see* Section 15.10 of the Energy Bureau's Regulation 8543, known as the *Regulation on Adjudicative Procedures, Notices of Noncompliance, Rate Review and Investigations*), it is respectfully submitted that this brief extension should not have an impact in the proceedings.

**WHEREFORE**, it is respectfully requested that this honorable Energy Bureau grant an extension of five (5) days to file the Memorandum of Law in support of the request for confidential treatment of Exhibit 1 to the *Motion in Compliance with Resolution and Order from March 19, 2024, and Request for Confidential Treatment* filed on May 2, 2024.
