SUBJECT: Resolution and Order to Modify  
the Schedule of Progress Report Submission  
and Compliance Hearings.

RESOLUTION AND ORDER

On July 12, 2024, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("July 12 Order") through which determined that subsequent Compliance Hearings would be held at least ten (10) calendar days after a Progress Report was filed. For that, the Energy Bureau included a calendar schedule in the July 12 Order for the submission of the Interconnection Progress Report and subsequent Compliance Hearings.

At the last Compliance Hearing held on February 24, 2025 ("February 24 Hearing"), the Energy Bureau addressed at the bench that it noticed a significant improvement in the number of interconnections achieved and, therefore, it will revise the further number of Compliance Hearings scheduled in the July 12 Order.

After evaluating the last few Interconnection Progress Reports filed by LUMA, the Energy Bureau **DETERMINES** that beginning with the Progress Report to be submitted in May 2025, the schedule for the (i) Progress Report and Power Point Presentation filing; and (ii) the Compliance Hearing<sup>1</sup> will be as described in the table below:

For the Compliance Hearings, as previously established by the Energy Bureau, LUMA **SHALL**: (i) provide all relevant representatives with all pertinent documents for the compliance hearings; (ii) make sure said representatives be ready to answer questions that the Energy Bureau staff and/or Commissioners may have; and (iii) timely file a copy of any Power Point presentation, visuals or materials that LUMA intends to use during the Compliance Hearings.

Notwithstanding, the Energy Bureau **RESERVE** its decision to reinstate additional Compliance Hearings if subsequent Progress Reports show deviations in the average days elapsed to complete an interconnection process, or any other issues that could affect the distributed generation interconnections.



Be it notified and published.




