**MOTION INFORMING IDENTIFICATION OF FUNDING
FOR APRIL 2025 PENSION PAYMENTS**

TO THE HONORABLE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority (PREPA), through its undersigned counsel, and respectfully States and Prays as follows:

1. On March 24, 2025, this Honorable Bureau issued a Resolution and Order ("March 24 R&O") directing PREPA to expeditiously file a petition seeking a temporary rate adjustment pursuant to Section 6.25(d) of Act 57-2014, in order to ensure the continuity of pension payments beginning in April 2025.

2. PREPA hereby informs the Bureau that, in coordination with the Government of Puerto Rico and the Financial Oversight and Management Board ("FOMB"), it has identified funding to cover the pension payments corresponding to the month of April 2025.

3. These funds will be sourced from a reapportionment as agreed upon with the FOMB.

4. PREPA remains committed to securing sustainable and long-term solutions for the funding of its pension obligations and will comply with all

directives issued by the Bureau in connection with the ongoing rate review process.

WHEREFORE, PREPA respectfully requests that the Bureau take notice of the foregoing and deem PREPA to have complied with the directive in the March 24 R&O, as it pertains to securing funds for the April 2025 pension payments.
