RESOLUTION

On March 3, 2025, CEN JUNCOS SOLAR, LLC ("CEN JUNCOS") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Motion to Request Confidential Treatment of 2025 Gross Revenues Report* ("March 3 Motion"), with the following documents:

- 1. Unredacted version *Gross Revenue and Financial Statements Report Electric Power Companies* (Form NEPR-B05).
- 2. Redacted version Gross Revenue and Financial Statements Report Electric Power Companies (Form NEPR-B05).

In the March 3 Motion CEN JUNCOS requested that all the information contained in the motion and the attached documents be granted confidential treatment.

Section 4.02(A) of Regulation 8701¹ requires that that all electric service companies must inform their Annual Gross Revenue within sixty (60) days after the end of the preceding Natural Year. The form established by the Energy Bureau for this information is the *Gross Revenue and Financial Statements Report* (Form NEPR-B05).

CEN JUNCOS submitted redacted and unredacted versions of the Form NEPR-B05 complying with Section 6.15 of Act 57-2014², Section 1.15 of Regulation 8701 and the *In Re: Policy on Management of Confidential Information in Procedures before the Commission*, CEPR-MI-2016-009, August 31-2016 Resolution ("Confidential Treatment Resolution").

The Energy Bureau **DETERMINES** CEN JUNCOS has complied with Section 4.02 of Regulation 8701 submitting Form NEPR-B05.

The Energy Bureau **TAKES NOTICE** of the Information presented by CEN JUNCOS in the March 3 Motion and upon an examination of the arguments brought forth by CEN JUNCOS, the Energy Bureau **DENIES** CEN JUNCOS request for confidential treatment to the motion and its redacted Form NEPR-B05 included as Attachment 2 since the motion and Attachment 2 doesn't contain confidential information and thus doesn't need confidential treatment, and **GRANTS** confidential designation and treatment to the unredacted version of the *Gross Revenue and Financial Statements Report Electric Power Companies* (Form NEPR-B05), included as Attachment 1, under Act 57-2014 and Regulation 8701.

The Energy Bureau **ORDERS** the Clerk's office to remove Attachment 1 of the March 3 Motion since it has been granted confidential treatment and maintain the motion with Exhibit 2 as a public document.
