
RESOLUTION

On March 27, 2025, the Puerto Rico Electric Power Authority (“PREPA”), filed before the Energy Bureau of the Puerto Rico Service Regulatory Board (“Energy Bureau”) a document titled *Motion in Compliance with March 20<sup>th</sup> Order* (“March 27 Motion”). Through the motion, PREPA identified the specific budgetary lines from which funds can be reallocated to fulfill the Oliveras and Estela case settlement. PREPA identified within its Non-Labor/Other Operating Expenses the lines form (a) IT-Maintenance & Corporate Services, and (b) External Audit Services.

PREPA requests the Energy Bureau to authorize to review the Fiscal Year 2024 (“FY24”) PREPA HoldCo Non-Labor Budget to include an increase of \$2.0 Million dollars in the Other Income Line for PREPA to cover the settlement reached in the Oliveras and Estela Case.

Upon review of PREPA’s argument, consistent with the Energy Bureau’s determination on the Maldonado-Laureano’s case settlement<sup>1</sup>, the Energy Bureau **TAKES NOTICE** of the March 27 Motion, **DEEMS** PREPA in compliance with the March 20, 2025 Resolution and Order, and **APPROVES** the budget reallocation as proposed.




