**INFORMATIVE MOTION REGARDING PRIOR FILINGS COMPLYING WITH
INTERVENTION AND DISCLOSURE REQUIREMENTS**

TO THE HONORABLE ENERGY BUREAU AND HEARING EXAMINER:

COMES NOW the Sistema de Retiro de los Empleados de la Autoridad de Energía Eléctrica (“SREAEE”), through the undersigned counsel, and respectfully STATES and INFORMS:

1. On April 2, 2024, SREAEE timely filed a **Petition for Intervention and Request for Notice** in the above-captioned proceeding, pursuant to Section 3.5 of Act No. 38-2017, the Uniform Administrative Procedure Act of the Government of Puerto Rico, and the applicable rules governing interventions before the Energy Bureau. The Petition specifically addressed SREAEE’s interests in the proceeding related to the pension obligations of the Puerto Rico Electric Power Authority (“PREPA”).
2. Pursuant to the procedural calendar and requirements established by the Energy Bureau, including the mandate that motions for intervention be filed prior to April 30, 2025, SREAEE’s Petition for Intervention was duly and timely submitted.

3. Additionally, on March 27, 2025, SREAEE filed an **Informative Motion**, accompanied by relevant financial documentation, to comply with the Energy Bureau's Resolution and Order dated February 12, 2025. This filing included: (a) a detailed statement of PREPA's outstanding pension debt to the Retirement System through February 28, 2025, and (b) a forecast of estimated cash inflows and outflows of the Retirement System Trust through December 2025.
4. To date, SREAEE has not received a resolution or response from the Energy Bureau regarding its Petition for Intervention nor acknowledgment of the informative submission regarding pension liabilities.
5. Considering the procedural schedule, SREAEE respectfully calls the attention of the Energy Bureau and the Hearing Examiner to the fact that it has duly complied with the requirements for intervention and the obligation to disclose economic information related to PREPA's pension obligations.
6. SREAEE respectfully requests that the Energy Bureau take notice of its prior filings and consider that SREAEE has satisfied the procedural prerequisites to participate as an intervenor in this rate review proceeding.

WHEREFORE, SREAEE respectfully submits this motion to bring these facts to the Energy Bureau's attention and requests any further relief deemed just and necessary.
