
Hearing Examiner's Order Revising Deadline for Rate Case Application

On Saturday, April 26, 2025, LUMA filed an "Urgent Request on Deadline to Submit Revenue Requirement Application in Light of April 21 Energy Bureau Order." LUMA requests a revision of the Energy Bureau's Order of April 21, 2025. Per that revision, there would be no "prepetition" filing on April 30, 2025. Rather, LUMA would submit a single application on July 3, 2025. That application, as I understand LUMA's request, would contain all the elements required by the Energy Bureau's April 21 Order, as I clarified and elaborated on those elements in my Order of April 25, 2025.

Per my delegated authority, which includes authority to set the procedural schedule, I grant LUMA's motion. As stated in my Order of April 25, 2025, nothing precludes LUMA from proposing a rate adjustment to address emergency or temporary events under section 6.25(d) of Act 57-2014.

At tomorrow's conference (10.30 am AS), we will discuss the implications of today's Order for the procedural schedule that I attached to my Order of April 25, 2025. To assist that discussion, I will likely circulate by email a draft revised schedule later this evening. LUMA should be prepared to address my wish to maintain the dates for discussions of rate design as set forth in the procedural schedule attached to my Order of April 25, 2025.


