**MOTION REQUESTING EXTENSION OF TIME TO COMPLY WITH RESOLUTION AND
ORDER DATED APRIL 7, 2025**

TO THE HONORABLE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority ("PREPA") through its undersigned legal counsels and respectfully informs and requests as follows:

1. On April 7, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("April 7 Order") in the above-captioned proceeding, directing PREPA and the Puerto Rico Public-Private Partnerships Authority ("P3 Authority") to submit additional information and proposed revisions to the First Amendment to the Puerto Rico Thermal Generation Facilities Operation and Maintenance Agreement ("GOMA") within five (5) days of notification of said Order.
2. PREPA is currently engaged in discussions with the P3 Authority and Genera PR, LLC ("Genera") concerning the matters raised by the Energy Bureau in the April 7 Order.
3. In light of the ongoing nature of these interagency and contractual discussions, and the need to properly evaluate the scope and implications

of the Energy Bureau's directives, PREPA respectfully requests a short extension of five (5) additional labor days to comply with the April 7 Order.

4. This request is made in good faith and to ensure that any filing made before the Energy Bureau reflects a thorough assessment of the issues raised and a coordinated response by the relevant parties.

WHEREFORE, PREPA respectfully requests that the Energy Bureau grant an extension of five (5) additional labor days from the original deadline to comply with the directives set forth in the April 7, 2025, Resolution and Order.
