**MOTION TO REQUEST ADDITIONAL EXTENSION OF TIME TO SUBMIT FEBRUARY  
B2A REPORT**

**TO THE HONORABLE PUERTO RICO ENERGY BUREAU:**

**COMES NOW** the Puerto Rico Electric Power Authority ("PREPA") through its undersigned legal representation and respectfully informs and requests as follows:

1. As part of the Resolution and Order issued on June 25, 2023, regarding the Annual Budgets for Fiscal Year 2024, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") established several financial reporting requirements for PREPA, including the submission of a monthly Budget to Actual ("B2A Report") for HydroCo and HoldCo.
2. On June 26, 2024, the Energy Bureau issued another Resolution and Order ("June 26 Order") concerning the review of the FY 2025 Budget, confirming that all existing reporting requirements remain in full force and effect.
3. On April 15, 2025, PREPA requested an extension until April 25, 2025, to submit the February 2025 B2A Report. However, today, PREPA requested from the Financial Oversight and Management Board for Puerto Rico

("FOMB") an additional extension until Tuesday, April 29, 2025, to finalize and submit the corresponding report.

4. PREPA will continue to work expeditiously to complete the February 2025 B2A Report and submit it to both the Energy Bureau and the FOMB as soon as possible.
5. Accordingly, PREPA respectfully requests that the Energy Bureau grant an extension until April 29, 2025, to submit the February 2025 B2A Report. This request is made in good faith to ensure the quality and reliability of the information submitted and not for purposes of delay.

**WHEREFORE**, PREPA respectfully requests that the Energy Bureau: (a) take NOTICE of the information provided herein; and (b) GRANT the extension of time requested until April 29, 2025.
