SECOND INFORMATIVE MOTION

TO THE HONORABLE ENERGY BUREAU:

COMES NOW EnFin, Corp. ("EnFin"), through the undersigned counsel, and respectfully states and informs as follows:

In EnFin's previous filing today, it was indicated that payment of the "the filing fees as established in section 2.03(A)(1), 2.03(A)(2)(a), and 3.07(a) and (c) of Regulation 8701 [...] was completed via ACH transfer on May 29, 2025." Additionally, it was indicated that:

The justification for the amount paid is detailed in the table attached as Attachment II. The calculation was made using the most conservative criteria possible **even though it may result in EnFin making an overpayment** in order to cover any lack of specificity in Regulation 8701. *Informative Motion* of May 30, 2025, at p. 1.

Notwithstanding the foregoing, the PREB notified a deficiency with respect to the requirement in Section 3.07(c). Payment of the deficiency is also made, and evidence is herein included in **Attachment I**. It is further requested that the amount paid is not publicly disclosed based on the same legal reasons presented in Part II of the *Informative Motion* filed previously today.

**I. Conclusion**

**For all the foregoing reasons**, EnFin, Corp. respectfully requests that the Honorable Puerto Rico Energy Bureau take notice of the foregoing and finds the payment evidenced to be sufficient under the terms of Regulation 8701.
