SUBJECT: Motion to Reiterate LUMA’s May
15th Budget Amendment Request

**MOTION TO REITERATE LUMA’S MAY 15TH BUDGET AMENDMENT REQUEST
TO THE HONORABLE PUERTO RICO ENERGY BUREAU:**

COME NOW LUMA Energy, LLC (“ManagementCo”), and **LUMA Energy ServCo, LLC** (“ServCo”), (jointly referred to as “LUMA”), and respectfully state and request the following:

1. On May 15, 2025, LUMA submitted to this Puerto Rico Energy Bureau (“Energy Bureau”) a *Motion Submitting Amendment to FY2025 T&D Budget* (“May 15th Motion”), whereby it sought prompt approval of a \$15.6 million reallocation within LUMA’s Operating Budget, from the Support Services Department to the Customer Experience, Operations, and Utility Transformation Departments, in order to better align resources with operational priorities. Moreover, LUMA requested approval of a \$13.9 million reallocation within the Non-Federal Capital (“NFC”) Budget to advance the Electric System Priority Stabilization Plan, resiliency initiatives, and critical capital improvements.

2. In its May 15th Motion, LUMA noted that all proposed reallocations remain within their respective budget categories and no funds are transferred between the Operating Budget and the Non-Federal Capital Budget.

3. LUMA’s May 15th Motion is still pending consideration by this Energy Bureau.

4. It is crucial that the Energy Bureau address and approve the requested amendment expeditiously to enable LUMA to proceed with necessary expenditures in June. Timely approval will allow LUMA to allocate resources effectively, maintaining momentum on essential maintenance and capital improvements initiatives.

5. Accordingly, LUMA hereby respectfully reiterates its request that the Energy Bureau approve the proposed amendment to the FY2025 T&D Budget, as detailed in its May 15th Motion.

WHEREFORE, LUMA respectfully requests that this Energy Bureau **rule** on LUMA's May 15th Motion; and **grant** the relief requested therewith.
