MOTION TO REQUEST CONFIDENTIAL TREATMENT OF FINANCIAL INFORMATION FOR FISCAL YEAR 2024

TO THE HONORABLE ENERGY BUREAU:

COMES NOW CEN Juncos Solar, LLC ("Juncos Solar"), represented by the undersigned legal counsel, and very respectfully prays and requests:

1. Section 4.02(E) of the Amendment to Regulation No. 8618 on Certification,
Annual Fees, and Operational Plans for Electric Service Companies in Puerto Rico,
Regulation 8701 of the 17th of February 2016, ("Regulation 8701") (as amended by
Regulation No. 9182) requires electrical service companies whose gross revenues are
equal to or less than three million dollars (\$3,000,000.00), to file compiled financial
statements, within 120 days of the end of an electrical service company's fiscal year,
that must be signed by an authorized representative of the electric service company.
The signature of the authorized representative shall constitute a sworn certification,
under penalty of perjury, that said information is correct and complete. The financial
statements can be compiled by a Certified Public Accountant (CPA) authorized to

practice said profession in Puerto Rico or any other jurisdiction in the United States of America. CEN Juncos Solar, LLC's fiscal year ended on December 31.

- On August 30, 2025, Juncos Solar kindly requested a forty-five (45) day extension for the filing of (1) the Compiled Financial Statements certified by a CPA, and (2) the Gross Revenues and Financial Statement Form (NEPR-B05). The requested extension would be until June 14, 2025.
- 3. On June 4, 2025, the Honorable Energy Bureau issued a Resolution and Order granting Juncos Solar until June 14, 2025 to file its Compiled Financial Statements and Gross Revenues and Financial Statement Form (NEPR-B05).
- 4. First, Juncos Solar hereby complies by attaching its Gross Revenues and Financial Statement Form (NEPR-B05) duly signed by a CPA. (**Attachment 1**)
- 5. Second, Juncos Solar hereby complies by attaching its Compiled Financial Statements certified by a CPA. (Attachment 2)
- 6. Thirdly, Juncos solar submits a detailed explanation of the discrepancies between the initial Gross Revenues and Financial Statement Form (NEPR-B05) submitted on March 3, 2025 and the compiled financial statements for the Natural Year ending on December 31, 2024, in compliance with Section 4.02(H) of Regulation 8701, including all supporting documents certified by a CPA. (**Attachment 3**)
- 7. Juncos Solar requests that confidential treatment be afforded to this motion and its corresponding attachments. Section 6.15 of Act No. 57 of May 17, 2014, as amended, 22 L.P.R.A. § 1054n, provides:

If any person who is required to submit information to the Energy [Bureau] believes that the information to be submitted has any confidentiality

privilege, such person may request the [Bureau] to treat such information as such, subject to the following:

- (a) If the Energy [Bureau], after the appropriate evaluation, believes such information should be protected, it shall grant such protection in a manner that least affects the public interest, transparency, and the rights of the parties involved in the administrative procedure in which the allegedly confidential document is submitted.
- (b) To such purposes, the Energy [Bureau] shall provide access to the document or the privileged portion of the document only to the lawyers and external consultants involved in the administrative process after the execution of a confidentiality agreement.
- (c) The Energy [Bureau] shall keep the documents submitted for its consideration out of public reach only in exceptional cases. In these cases, the information shall be duly safeguarded and delivered exclusively to the personnel of the Energy [Bureau] who needs to know such information under nondisclosure agreements. However, the Energy [Bureau] shall direct that a non-confidential copy be furnished for public review.
- (d) The Energy [Bureau] shall swiftly act on any privilege and confidentiality claim made by a person subject to its jurisdiction by means of a resolution to such purposes before any allegedly confidential information is disclosed.
- 8. In turn, Section 1.15 of the Regulation No. 8701 provides that when a person who is required to submit information to the Energy Bureau considers such information to be privileged or confidential, the person shall identify the information it deems privileged or confidential, request the Energy Bureau to protect such information, and present arguments supporting the privilege or confidentiality claim. The Energy Bureau shall evaluate the petition and, if it concludes the information merits protection, it shall proceed pursuant to Section 6.15 of Act No. 57.

9. Juncos Solar respectfully requests that all the information contained in this motion

and the documents attached hereto be kept confidential in accordance with Section 1.15

of Regulation 8701. Juncos Solar is a privately held company. Its financial information is

confidential, of sensitive nature, and not available to the public. the disclosure of Juncos

Solar's financial information would place it at a competitive disadvantage with respect to

other market participants and cause it economic harm.

10. In compliance with Section 6.15 of Act 57-2014, Section 1.15 of Regulation 8701

and the In Re: Policy on Management of Confidential Information in Procedures Before

the Commission, CEPR-MI-2016-0009, August 31-2016, Resolution ("Confidential

Treatment Resolution"), Juncos Solar is filing a redacted and unredacted version of the

information and documents for which it is requesting Confidential Treatment.

WHEREFORE, CEN Juncos Solar, LLC respectfully requests it be deemed in

compliance with Section 4.02(E) of Regulation No. 8701 and that this motion and its

attachments be granted a confidential treatment.


