SUBJECT: Resolution and Order pertaining to Request for Microgrid Registration

RESOLUTION AND ORDER

On May 14, 2025, Nuscan CSP ("Nuscan") submitted a *Request for Microgrid Registration* (the "Request") before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") for a facility to be located at Solar 3A Carr 1 Calle San Carlos in the Municipality of Caguas, Puerto Rico. As part of the Request, Nuscan include the following documents:

1. *Formulario de Registro de Microrred*
2. *Hoja Complementaria*

Regulation 9028<sup>1</sup> establishes the applicable requirements for microgrid registration. Nuscan's filing includes only the application forms and fails to provide any other documentation necessary to demonstrate compliance with Regulation 9028 for the proposed microgrid. Specifically, the submission lacks: (i) a description of the microgrid, including, without limitation, its generation resources and other system resources (e.g., storage, inverters, and other major electrical equipment); (ii) a delineation of the microgrid's physical boundaries; (iii) a description of the properties where each component of the microgrid will be installed, as well as evidence of Nuscan's ownership of, or legal right to use, such properties; (iv) the certified design of the microgrid; (v) an indication of whether the microgrid intends to export energy to the Puerto Rico electric grid; (vi) details regarding the proposed point of interconnection; (vii) a certification of compliance with applicable codes and standards; (viii) an explanation of how the project complies with the technical requirements for the type of microgrid proposed (in this case, renewable); (ix) an explanation of the method to be used to demonstrate compliance with the applicable provisions of Regulation 9028 (submit operational plan); and (x) proof of payment of the applicable filing fee or a justification for its exemption. The foregoing list is not intended to be exhaustive, nor does it necessarily represent the totality of information required to demonstrate compliance with Regulation 9028. Once the missing information is submitted, additional documentation or clarifications may be necessary to complete the evaluation of regulatory compliance. In addition, Nuscan may request modifications or exceptions to compliance with any applicable regulatory requirement; however, each such request must be expressly identified and supported by a clear and well-founded justification, including all relevant legal, technical, or practical grounds. The Energy Bureau will evaluate any such request on a case-by-case basis in accordance with the applicable legal and regulatory framework.

Based on the foregoing, the Energy Bureau **DETERMINES** that the Request submitted by Nuscan is incomplete. Accordingly, the Energy Bureau **GRANTS** Nuscan **twenty (20) days**, from the notification of this Resolution and Order, to submit all necessary information and documentation required to demonstrate compliance with the applicable provisions, in order to enable the proper evaluation of the Request.

The Energy Bureau **AUTHORIZES** members of its staff and consultants to hold informal technical meetings with representatives and/or consultants of Nuscan for the purpose of clarifying the requirements set forth in this Resolution and Order, as well as other matters related to the Request. However, it must be clearly understood that Energy Bureau staff and



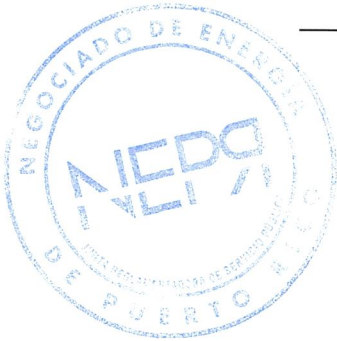
