MOTION REQUESTING EXTENSION OF TIME TO COMPLY WITH RESOLUTION AND ORDER TO THE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority ("PREPA"), through its counsel of record, and respectfully submits and prays as follows:

- 1. On February 28, 2025, PREPA submitted a filing before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") titled Motion Submitting Form NEPR-B05 ("February 28 Motion"), which included: (i) Form NEPR-B05, (ii) PREPA's financial statements for Fiscal Year 2021–2022, and (iii) a gross revenue monthly breakdown from July 1, 2023, to June 30, 2024.
- 2. On June 3, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order in the captioned case, directing PREPA to submit, within fifteen (15) calendar days: (i) its 2024 Gross Revenue Report, including the monthly breakdown for July through December 2024, duly certified by PREPA's Executive Director; and (ii) a copy of PREPA's audited financial statements for Fiscal Year 2024, if available, or an explanation of their unavailability and expected completion date.
- 3. As stated in the Resolution and pursuant to Section 4.02(G) of Regulation 9182, the information required by the Energy Bureau must be accompanied by a resolution of

PREPA's Governing Board accepting and approving the gross revenue report. PREPA

respectfully informs the Energy Bureau that its Governing Board is scheduled to hold its

next regular meeting on June 25, 2025. Accordingly, PREPA must await the Board's

consideration and approval before finalizing and submitting the required information.

4. Therefore, PREPA respectfully requests a short extension of time, until June 30, 2025,

to comply with the requirements set forth in the June 3, 2025, Resolution and Order. This

additional time is necessary to allow PREPA to secure the required approvals and to

ensure the completeness and accuracy of the information to be filed.

WHEREFORE, PREPA respectfully requests that the Energy Bureau grant an

extension until June 30, 2025, to comply with the Resolution and Order issued on June 3,

2025, in the above-captioned proceeding.
