SUBMISSION OF MONTHLY REPORT ON SYSTEM RELIABILITY METRICS FOR **APRIL AND MAY 2025**

TO THE PUERTO RICO ENERGY BUREAU:

COMES NOW, LUMA ENERGY SERVCO, LLC ("LUMA"), through the undersigned legal counsel and respectfully states and requests the following:

T. **Introduction and Procedural History**

The requirement to submit quarterly reports on specified system data of the Puerto Rico Electric Power Authority ("PREPA") arises under the Resolution and Order issued by the Puerto Rico Energy Bureau ("Energy Bureau") on May 14, 2019, in this proceeding. In accordance with the Resolution and Order issued on December 30, 2020, the quarterly system data is due on the 20th day of the month after each quarter closes.¹

¹ In a Resolution and Order of August 18, 2022, this Energy Bureau granted LUMA's request to align the quarterly filings of system data in this proceeding with the filing of the quarterly operation report submitted after each quarter of the fiscal year closes. Consequently, the quarterly reports are now due in the following months: October (with data for the months of July through September), January (with data for the months of October through December), April (with data for the months of January through March), and July (with data for the months of April through June). See Request for Modification of Schedule to File System Data and Submission of Quarterly Performance Metrics Report for June 2022 ("Request to Modify Schedule") and Exhibit 1 (Schedule of proposed changes) and Exhibit 2 (Proposed Filing Schedule).

Pursuant to Section 5.6 of the Puerto Rico Transmission and Distribution System Operation and Maintenance Agreement ("T&D OMA"),² LUMA, as an agent of PREPA, submits systems data regarding the Transmission and Distribution System ("T&D System").

On May 16, 2025, the Puerto Rico Energy Bureau issued a *Resolution and Order* entitled *Response to LUMA's January 15 Motion, Response to Genera's February 3 and February 10 Motions, System Reliability Metric Reporting Frequency, and Additional System Reliability Metrics* (the "May 16th Order"). The Bureau directed LUMA and Genera to provide within twenty (20) calendar days, all relevant information in their responses to the Requirements of Information ("ROIs") set forth in Attachment A to the May 16th Order, which includes ROIs specifically directed to LUMA ("LUMA ROIs"). *Id.* at 11, Attachment A. Furthermore, the Bureau directed LUMA to begin reporting the Reliability Metrics set forth in Section C, paragraph a, to the May 16th Order, by the 20th day of the following month, starting in June 2025.

Following the Energy Bureau's May 16th Order, on June 5, 2025, LUMA submitted the *Motion in Compliance with Resolution and Order of May 16, 2025* (the "June 5th Motion"). Through the June 5th Motion, LUMA submitted comprehensive responses to the LUMA ROIs (the "LUMA June 5th Responses"). The June 5th Responses provided clear explanations of LUMA's reliability metric methodologies and addressed the feasibility and limitations associated with reporting proposed system-level reliability metrics.

II. Submission of System Reliability Metrics for April and May 2025

In further compliance with the Energy Bureau's May 16th Order, LUMA hereby submits for the months of April and May 2025, the System SAIDI (T&D FYTD), System Monthly SAIDI

(T&D), System SAIFI (T&D FYTD), and System Monthly SAIFI (T&D) metrics. This submission is accompanied by the Excel workbook entitled "Resumen Metricas Master_June2025.xlsx," ("Exhibit 1"), which contains the required reliability metrics in accordance with the directives set forth in the May 16th Order. See Exhibit 1, cells AZ136, AZ137, AZ140, AZ141, BA136, BA137, BA140, and BA141.

LUMA respectfully notes that the values reported for April and May 2025 are preliminary and, as such, remain subject to revision in future submissions as needed.

WHEREFORE, LUMA respectfully requests that this Honorable Bureau take notice of the aforementioned; accept the Monthly Report on System Reliability Metrics for April and May 2025.
