On June 24, 2025, the Energy Bureau received a copy of a letter sent to PREPA's Executive Secretary by LUMA's Vice President for T&D OMA Contract Management. The letter asked PREPA to supply, among other things, Responses to RFI questions 54 through 61 from my Order of March 24, 2025.

To avoid any confusion and any responsive letters: My Order of March 24, 2025, stated that respondents to the questions attached to that order "should integrate the answers into the Application or accompanying prefiled testimony, wherever it makes sense, citing the specific question by number." To the extent that LUMA's June 24 letter is asking for PREPA's responses to those questions separately from PREPA's testimony or application, the letter is incorrect.
