#### ECOELÉCTRICA, L.P.'s MOTION IN COMPLIANCE WITH ORDER

**COMES NOW** EcoEléctrica, L.P. ("EcoEléctrica"), by and through its counsel of record, and respectfully states as follows:

- On February 28, 2025, EcoEléctrica filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") its 2024 Gross Revenue Report (FORM NEPR-B-05).
- Furthermore, on March 19, 2025, EcoEléctrica submitted its Operational Report for 2025 (Form NEPR-B03). EcoEléctrica also provided evidence of payment for the filing of Form NEPR-B03. The referenced filing also included an update of EcoEléctrica's personal information. On the other hand, EcoEléctrica did not provide evidence of payment of the corresponding filling fee.
- 3. On April 9, 2025, EcoEléctrica submitted its financial statements for Fiscal Year 2024.
- 4. Subsequently, on the Resolution and Order of June 18, 2025, the Energy Bureau took notice that EcoEléctrica submitted its Operational Report, Annual Gross Revenue, and Financial Statements. The Energy Bureau also determined that EcoEléctrica complied with Section 2.03(A)(2) by submitting evidence of payment of the applicable filling fee. On the other hand, EcoEléctrica did not submit evidence of payment pertaining to its personal information update.

Therefore, on the Resolution and Order of June 18, 2025, the Energy Bureau ordered EcoEléctrica to submit evidence of payment within five (5) business days from the notification of this Resolution and Order and warned EcoEléctrica that failure to comply with this Resolution and Order may result in the imposition of an administrative fine, in accordance with Art. 6.36 of Act 57-2014.
- 6. However, the notification of the Resolution and Order of June 18, 2025, was made to ConWaste Puerto Rico (<u>jvazquez@conwastepr.com</u>; <u>jzczayas@conwastepr.com</u>; cotero@conwastepr.com), not EcoEléctrica nor its legal representatives. Therefore, EcoEléctrica was not aware nor was notified of this Resolution and Order until June 25, 2025.
- 7. In compliance with the Resolution and Order of June 18, 2025, please find attached the evidence of the payment made by ACH pertaining to EcoEléctrica's personal information update, as required. See Attachment A.

WHEREFORE, EcoEléctrica requests that the Energy Bureau take notice of the above, deem EcoEléctrica to be in compliance with the Resolution and Order of June 18, 2025, along with any other relief that the Energy Bureau deems just and proper.
