**NOTICE OF *PRO HAC VICE* APPEARANCE AND REQUEST FOR NOTICE
TO THE HONORABLE PUERTO RICO ENERGY BUREAU:**

COMES NOW Brett Ingerman, counsel herein, and respectfully states the following:

1. On May 14, 2025 the Supreme Court of Puerto Rico issued a Resolution, pursuant to Rule 12(f) of the Rules of the Supreme Court of Puerto Rico, 4 LPRA Ap. XXI-B, whereby it granted me *pro hac vice* admission to appear before the Puerto Rico Energy Bureau (“Energy Bureau”) in the captioned proceeding. *See* Exhibit 1.

2. Since December 14, 1994, I have been and presently am a member in good standing of the bar of the State of Maryland, where I regularly practice the law. My Maryland license number is 9412140078. Likewise, I have been a member in good standing of the bar of the District of Columbia, since January 9, 2006, where my license number is 495196. 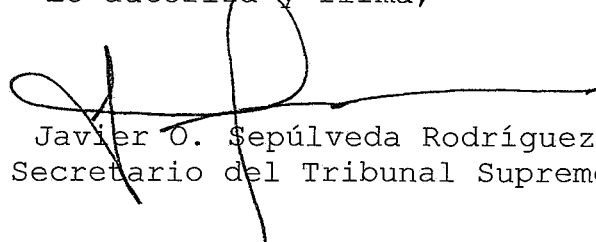
