Hearing Examiner's Order on Draft Public Notices

On February 12, 2025, the Energy Bureau established content and publication requirements for public notices relating to proposed new rates. On July 3, 2025, LUMA filed PREPA's rate application, including draft bilingual public notices.

I thank LUMA for this effort. Its draft notices comply with all February 12 requirements except: the blank fields need completion, and the intervention language needs clarification.

Approval with conditions: I approve the draft notices, subject to LUMA's taking these actions:

- Fill in the July 3, 2025 filing date.
- Add the missing revenue increase requests and average customer impacts for customers of different classes.
- Replace the intervention language with the following:

Any person may file a petition to intervene while this case is pending. But petitions filed since the July 3, 2025, application date risk rejection on grounds of delay to the proceeding or prejudice to existing parties.

Submission to the Energy Bureau: Within 2 calendar days of this Order, LUMA shall file the completed bilingual notices with the Energy Bureau in native format, for publication on the Energy Bureau's website.

Publication: Within 10 calendar days of this Order, LUMA shall publish the completed notices in at least one Puerto Rico newspaper of general circulation.

Proof of publication: Within 10 days of the newspaper's publication, LUMA shall file with the Energy Bureau an affidavit from the newspaper confirming the dates of publication and a copy of the printed notice as it appeared in the newspaper; and a printout or screenshot of the notice as posted on PREPA's and LUMA's website.
