RESOLUTION AND ORDER

I. Introduction

On March 18, 2025, the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("March 18 Resolution") granting SunE XVI Lessor, LLC ("SunE XVI") Request for Certification for Distributed Generator with aggregated capacity of one (1) MW or more, under Section 2.02(A)(1) of Regulation 8701.<sup>1</sup>

In compliance with Regulation 8701 SunE XVI has submitted the required forms and reports including:

1. *Gross Revenue and Financial Statements Report Electric Power Companies* (Form NEPR-B05)<sup>2</sup>.
2. *Personal Information Electric Power Companies* (Form NEPR-B01).<sup>3</sup>
3. Financial Statements for Fiscal Year 2024.<sup>4</sup>

According to the administrative record SunE XVI is still pending for filing its annual *Operational Report for Electric Power Companies* (Form NEPR-B03), and to pay the applicable filing fee.

II. Applicable Laws and Regulations

Section 2.02 of Regulation 8701 requires that all electric service companies must submit an Operational Report with the frequency corresponding to their classification<sup>5</sup>. The required format for such reports is the *Operational Report for Electric Power Companies* (Form NEPR-B03), as established by the Energy Bureau.

In addition, Section 2.03(A)(2) of Regulation 8701 mandates that all electric service companies submitting an operational report must pay the applicable fee.

III. Conclusion

The Energy Bureau **DETERMINES** SunE XVI **DID NOT COMPLY** with Section 2.02 of Regulation 8701 that requires filing its *Operational Report for Electric Power Companies* (Form NEPR-B03) and **DID NOT COMPLY** with Section 2.03(A)(2) that requires submitting evidence of payment of the applicable filing fee.

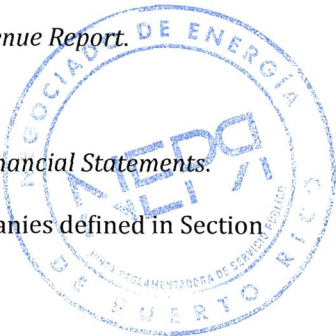



The Energy Bureau **WARNS** SunE XVI, that, under Art. 6.36 of Act 57-2014<sup>4</sup> non-compliance with this Resolution and Order; regulations and/or applicable laws may carry the imposition of fines and administrative sanctions.
