RESOLUTION AND ORDER

On March 3, 2025, Circon Renewable Energy, LLC ("Circon") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") the *Gross Revenue and Financial Statements Report Electric Power Companies* (Form NEPR-B05) for 2024, as required by Section 4.02(A) and (B) of Regulation 8701.¹

Circon did not file the following documents required by Regulation 8701:


1. *Operational Report for Electric Power Companies* (Form NEPR-B03), required by Section 2.02(A)(1) of Regulation 8701 with payment of the applicable fee according to each type of electric service to be provided.²
2. Financial Statements for Fiscal Year 2024, required by Section 4.02 (E) and (F) of Regulation 8701 within one hundred and twenty (120) days after the end of their Fiscal Year.³

The Energy Bureau **TAKES NOTICE** of the *Gross Revenue and Financial Statements Report Electric Power Companies* (Form NEPR-B05) filed on March 3, 2025, and **DETERMINES** it **COMPLIED** with Section 4.02 of Regulation 8701.

The Energy Bureau **ORDERS** Circon, **within fifteen (15) days** from the notification of this Resolution and Order, to file its *Operational Report for Electric Power Companies* (Form NEPR-B03), with the corresponding fee(s); and its Financial Statements for Fiscal Year 2024.

The Energy Bureau **WARNS** Circon, that, under Art. 6.36 of Act 57-2014⁴ non-compliance with this Resolution and Order; regulations and/or applicable laws may carry the imposition of fines and administrative sanctions.

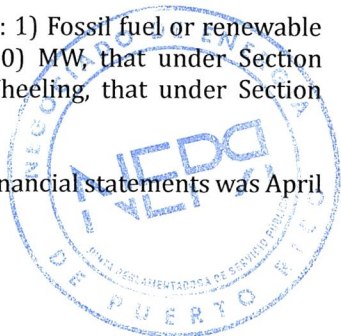




² According to Circon's 2024 Operational Report, its Types of Electric Service are: 1) Fossil fuel or renewable energy generation with aggregated capacity of more than one hundred (100) MW, that under Section 2.02(A)(2) must file an Operational Report every three (3) years; and 2) Wheeling, that under Section 2.02(A)(5) must file an Operational Report every three (3) years.


³ Circon's Fiscal Year is from January 1 to December 31. The due date for filing its financial statements was April 30, 2025.
