**SECOND MOTION FOR EXTENSION OF TIME TO COMPLY WITH JULY 2, 2025
RESOLUTION AND ORDER**

TO THE HONORABLE ENERGY BUREAU,

COMES NOW the Puerto Rico Electric Power Authority (hereinafter, "PREPA") through its undersigned legal representation and, very respectfully, informs and requests as follows:

1. On July 2, 2025, the Energy Bureau issued a Resolution and Order ("July 2 Order") in the above-captioned case, directing PREPA to submit by July 7, 2025, all supporting documents, spreadsheets, models, and other relevant files in their native editable formats, with all underlying formulas, links, and source data preserved, in connection with the Petition for Approval of Amendment to the PPOA with Energiza, LLC.

2. PREPA filed a motion requesting an initial extension until July 11, 2025, to gather and prepare the required documentation. That motion was submitted in good faith and reflected PREPA's understanding at the time of the scope of the materials required to comply with the July 2 Order.

3. However, the renewal of the consultants' contracts for fiscal year 2026 took longer than expected and temporarily affected the pace of the evaluation of the Energy Bureau's request. Once this situation was resolved, PREPA's consultants resumed their work and have continued to diligently compile the requested data. Nevertheless, they have determined that additional time is necessary to organize and submit several key components in the proper format, including:

- a. Source documentation from the PPOA supporting the assumptions in the summary tables;
- b. Historical fuel pricing data, as shown in the referenced line graph;
- c. Fiscal Plan projections supporting the comparisons between Energiza's projections and PREPA's baseline generation costs.

4. In light of the foregoing, PREPA respectfully requests an additional extension of five (5) business days, until July 18, 2025, to complete the compilation and filing of the required documentation in accordance with the Energy Bureau's directives.

5. This request is made in good faith, with the purpose of ensuring full and accurate compliance with the July 2 Order, and not for the purpose of causing undue delay.

WHEREFORE, PREPA respectfully requests that the Energy Bureau GRANT this Second Motion for Extension and allow PREPA until July 18, 2025, to comply with the requirements of the July 2, 2025, Resolution and Order.
