RESOLUTION AND ORDER

On June 12, 2025, the Puerto Rico Aqueduct and Sewer Authority ("PRASA") submitted a Microgrid Registration Form (the "Request for Microgrid Registration") to the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") for a facility to be located in the Municipality of Arecibo, Puerto Rico.

After conducting a preliminary evaluation of the documentation and explanations submitted by PRASA, the Energy Bureau deems the petition to be COMPLETE. Notwithstanding the foregoing, before the issuance of the final resolution in this case, the applicant must submit a certification of the microgrid design, duly signed and sealed by a licensed engineer. Accordingly, the Energy Bureau hereby INITIATES the formal evaluation process. Nevertheless, as part of its final detailed assessment of the petition, should it become necessary to request any additional information, the Energy Bureau will do so soon.

To conduct the pertinent evaluation in this case in an expedited manner, the Energy Bureau authorizes members of its staff and consultants to hold informal technical meetings with representatives and/or consultants of PRASA to clarify matters related to the Request for Microgrid Registration. However, it must be understood that Energy Bureau staff and consultants may not make binding representations or commitments on behalf of the Energy Bureau. The final authority regarding the evaluation and determination of the Request for Microgrid Registration relies exclusively on the Commissioners.
