SUBJECT: Resolution and Order about **Request for Certification**

RESOLUTION AND ORDER

On April 28, 2025, Accurate Solutions Corp. ("Accurate") submitted a Request for Certification Electric Power Companies ("Request for Certification") to the Energy Bureau of the Puerto Rico Public Service Regulatory Board (the "Energy Bureau") for a facility to be at Road 110 Km 28 in the Municipality of Aguadilla, Puerto Rico.

As part of the Request for Certification, Accurate submitted certain annexes and documents intended to demonstrate the company's financial resources and the adequacy of its human and financial capacity. However, the information provided is incomplete. In addition, Accurate failed to submit documentation related to contracts or legal transaction with PREPA or another electric power company, permits, authorizations and endorsements obtained to operate, do business and provide services in Puerto Rico and certification stating that the company has obtained all necessary permits to construct new facilities.

Regulation 8701¹ establishes the applicable requirements for the certifications of electric power companies. Accurate's filing provides no other documentation to demonstrate compliance with Regulation 8701 to be certified as an electric power company. Speciffically, the submission is missing the following:

- an explanation of the type of service Accurate propses to provide; (i)
- operational reports; (ii)
- a detailed list of the technical and professional qualifications of current personnel, (iii) as well as the profiles of individuals the company intends to recruit, in order to demonstrate their expertise and competency to operate and provide elecric power services:
- (iv) information regarding charges and rated, the company efforts to orient clients and promot efficient electric energy consumption and reports on improvements in electric power system behavior, all of which must be included as part of the operational report;
- (v) payment corresponding to the operational report;
- documentation related to contracts or legal transaction with PREPA or another (vi) electric power company;
- (vii) copies of the permits, authorizations, and federal, state, and municipal endorsements the company has obtained in order to operate and do business in Puerto Rico and provide electric power service in Puerto Rico;
- (viii) payment of the applicable fees for the presentation of the Personal Information and Request for Certification pursuant to Section 2.03 and Section 3.07 of Regulation 8701;
- (ix) identification of the power sources used;
- (x) a detailed description including specifications, nominal capacity, net capacity of each unit, plants or technology used in service provision;
- (xi) documentation supporting the specifications of the plants or technology used in the provision of service;

- (xii) the capacity of generating units;
- (xiii) the net capacity of plants or generation units;

- (xiv) the description of the geographical area withing Puerto Rico that will be affected by the proposed service; and
- (xv) evidence of compliance with all requirements of Section 3.03and 3.07 of Regulation 8701.

Based on the foregoing, the Energy Bureau **DETERMINES** that the Request for Certification submitted by Accurate is **INCOMPLETE** and **GRANTS** Accurate to submit, within **thirty (30) days** from the notification of this Resolution and Order, all necessary information and documentation required to demonstrate compliance with the applicable provisions, to enable the proper evaluation of the Request for Certification.

The Energy Bureau authorizes members of its staff and consultants to hold informal technical meetings with representatives and/or consultants of Accurate to clarify the requirements listed in this Resolution and Order, as well as other matters related to the Request for Certification. However, it must be understood that Energy Bureau staff and consultants may not make binding representations or commitments on behalf of the Energy Bureau. The final authority regarding the evaluation and determination of the Request for Certification rests exclusively with the Commissioners.
