**TO THE HONORABLE PUERTO RICO ENERGY BUREAU:**

**COME** now **LUMA Energy, LLC** and **LUMA Energy ServCo, LLC** (jointly referred to as “LUMA”), and respectfully state and request the following:

1. On July 2, 2025, LUMA filed a *Motion in Compliance with Resolution and Order of June 25, 2025 and Request for Confidential Treatment* (“July 2<sup>nd</sup> Motion”) in which LUMA submitted, among others, a document marked as Exhibit 2 (“July 2<sup>nd</sup> Exhibit 2”) and requested the Energy Bureau to maintain the July 2<sup>nd</sup> Exhibit 2 confidential as validated trade secret information under applicable laws and regulations, including the Energy Bureau’s Policy on Management of Confidential Information, CEPR-MI-2016-0009, issued on August 31, 2016, as amended on September 21, 2016, among other reasons, noting that LUMA would be submitting, within the next ten (10) days, a Memorandum of Law in support of such request for confidential treatment, in compliance with the mentioned Policy on Management of Confidential Information.

3. It is respectfully informed that, despite best efforts, additional time is needed to complete this Memorandum of Law. It is anticipated that this effort may be completed within the

next two (2) days. Considering the brevity of this extension, it is respectfully submitted that it should not have an impact on the proceedings.

**WHEREFORE**, LUMA respectfully requests that the Energy Bureau **take notice** of the aforementioned; **grant** the request stated herein to submit the Memorandum of Law in support of the July 2<sup>nd</sup> Exhibit 2 within the next two (2) days.
