SUBJECT: Filing of Personal Information Form. Filing of Gross Revenue Report. Order to show cause pending. Order to file Operational Report and filing fee.

RESOLUTION AND ORDER

On May 15, 2025, the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("May 15 Resolution") ordering Green Power Technologies Puerto Rico ("Green Power") to, within fifteen (15) days: (i) submit its gross revenue report and its financial statements for Fiscal Year 2024, and (ii) show cause why the Energy Bureau should not impose an administrative fine for its failure to comply with Act 57-2014¹ and Regulation 8701² by not submitting its gross revenue report and its financial statements on the regulatory dates.

On June 6, 2025, Green Power filed the following documents:

- 1. Updated *Personal Information Electric Power Companies* (Form NEPR-B01), required by Section 2.01 of Regulation 8701, with evidence of payment of the applicable filing fee required by Section 2.03(A)(1)(a).
- 2. Gross Revenue and Financial Statements Report Electric Power Companies (Form NEPR B05), required by Section 4.02 of Regulation 8701, reporting "\$0.00 (none)" as its gross revenue for Natural Year 2024.

On June 13, 2025, Green Power filed a Motion ("June 13 Motion") resubmitting the Updated *Personal Information Electric Power Companies* (Form NEPR-B01) previously filed on June 6. In the June 13 Motion Green Power reported the change of its authorized representative, as included in the updated Form NEPR-B01, as cause for its previous non-compliance, as requested in the May 15 Resolution:

This change also explains why prior notifications and official communications may not have been received, as they were sent to an outdated email address. We kindly request that all future correspondence be directed to the updated contact information listed above.

As of this date, Green Power has not submitted its *Operational Report for Electric Service Companies* (Form NEPR-B03), required by Section 2.02 of Regulation 8701, with evidence of payment of the applicable filing fee according to the type of electric service to be provided.

Moreover, Green Power has not yet submitted its Financial Statements for Fiscal Year 2024 as required by Section 4.02 of Regulation 8701 and the May 15 Resolution.

Upon reviewing the updated *Personal Information Electric Power Companies* (Form NEPR-B01) filed by Green Power on June 13, 2025, the Energy Bureau **DETERMINES** Green Power **COMPLIED** with Section 2.01 of Regulation 8701 by submitting Form NEPR-B01, and **COMPLIED** with Section 2.03(A)(1)(a) by submitting evidence of payment of the applicable filing fee for the updated personal information report.

The Energy Bureau **DETERMINES** Green Power **COMPLIED** with Section 4.02 of Regulation 8701 by submitting Form NEPR-B05 for Natural Year 2024, as ordered in May 15 Resolution.

The Energy Bureau **TAKES NOTICE** of the cause shown by Green Power in the June 13 Motion and **WAIVES** the administrative fine for the moment subject to compliance with the following filings.

Green Power **PARTIALLY COMPLIED** with the Energy Bureau's May 15 Resolution, as it submitted its Gross Revenue Report, but did not provide its FY2024 Financial Statements. As such the Energy Bureau **GRANTS** Green Power a **final ten (10) day term** to comply with the May 15 Resolution as it pertains to the filing of its FY24 Financial Statements.

The Energy Bureau **ORDERS** Green Power to submit its Operational Report and applicable fee within **ten (10) days** from the notification of this Resolution and Order.

The Energy Bureau **WARNS** Green Power that, in accordance with Art. 6.36 of Act 57-2014, non-compliance with this Resolution and Order will carry the imposition of fines.
