## **RESOLUTION AND ORDER**

In compliance with the Resolution issued by the Puerto Rico Court of Appeals on July 9, 2025, which ordered the stay of all proceedings related to the challenged procurement process, included but not limited to the execution of the contract for the services resulting from said process, and noting that no party has raised a claim regarding the Court of Appeals lack of jurisdiction following the issuance of the Resolution, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") **ORDERS** the immediate stay of all pending administrative matters in the instant case, related to the 800MW of temporary emergency generation, until a final determination by the Court of Appeals is issued.

The Energy Bureau **WARNS** the parties that this stay includes any administrative or contractual actions stemming from the temporary new generation acquisition process.

Taking the above into consideration, the Energy Bureau **STAYS** its determination regarding the *Petition to Intervene and Request of Access to Documents* filed on July 3, 2025 by Gothams Energy, LLC; the *Motion to Comply with the June 27, 2025 Resolution and Order*, filed on July 7, 2025 by the Puerto Rico Electric Power Authority ("PREPA"); the *Motion to Vacate Resolution of July 4, 2025*, filed on July 9, 2025 by Javelin Global Commodities US Holdings, Inc. ("Javelin"); the *Informative Motion in Compliance with the Resolution and Order Dated July 4, 2025*, filed on July 12, 2025 by PREPA; the *Supplemental and Informative Motion*, filed on July 12, 2025 by Javelin; and any other motion presented before us while the stay is in place.
