1. Section 2.01 (D) of the Amendment to Regulation No. 8618 on Certification, Annual Fees, and Operational Plans for Electric Service Companies in Puerto Rico, Regulation 8701 of the 17th of February 2016, (“Regulation 8701”) (as amended by Regulation No. 9182) requires electrical service companies to notify of any change in the information that an electric service company has submitted to the Energy Commission pursuant to this Section and submit the updated information within a period of ten (10) days following the occurrence of the change.
2. SunEdison is hereby complying with Section 2.02 (D) of Regulation 8701 and herein submitting the Personal Information Form Update (“form”). (**Attachment 1**). Please note, the information update pertains specifically to sections C, and D of the form.
