Denying PREPA's Motion for Reconsideration

Hearing Examiner's Order Denying PREPA's Motion for Reconsideration

In a prior discovery dispute, LUMA presented a "threshold objection": that PREPA's questioning of LUMA conflicted with PREPA's T&D OMA duty to cooperate with LUMA. My Order of July 18, 2025, rejected LUMA's objection, explaining that asking questions is not "inherently adversarial." On July 25, 2025, I clarified that PREPA's right to ask LUMA questions in discovery did not extend to cross-examining LUMA at the evidentiary hearing. Unlike discovery, I explained, cross-examination is inherently adversarial; but Act 120-2018 and the T&D OMA made the LUMA-PREPA relationship nonadversarial.

On August 11, 2025, PREPA moved for reconsideration of the July 25 Order. I deny reconsideration. It is true that Puerto Rico's Uniform Administrative Procedure Act "guarantees all parties in a formal adjudicatory proceeding the right to cross-examination." Motion at 6 (emphasis omitted). It is also true that the Energy Bureau cannot diminish a party's administrative-law rights. But PREPA omits the legal point that matters: a party can diminish its own administrative-law rights. When it signed the T&D OMA, PREPA did exactly that. Cross-examination, by definition, is adversarial. In signing the T&D OMA, PREPA formed with LUMA a relationship that is expressly nonadversarial. If PREPA wishes to cross-examine LUMA, they must amend their contract.

Without that OMA amendment, LUMA and PREPA remain nonadversaries. Under administrative law as I have always practiced it—PREPA having cited no contrary holding—cross-examination is confined to adversaries.
