## RESOLUTION AND ORDER

On June 18, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("June 18 Resolution"), concluding that the Request for Certification and the Request for Microgrid Registration submitted by Sonnel Power Solutions LLC ("Sonnel") is incomplete.

The Energy Bureau granted Sonnel to submit, within thirty (30) business days from the notification of the Resolution<sup>1</sup>, all the necessary information and documentation required to demonstrate compliance with the applicable provisions, to enable the proper evaluation of the Request for Certification and the Request for Microgrid Registration.

On July 18, 2025, Sonnel filed a document titled *Petition for Extension of Time* ("July 18 Motion") requesting a six (6) month extension starting August 4, 2025 (until February 4, 2026), to submit the remaining documentation necessary to complete its Requested for Certification and Microgrid Registration. Additionally, in the July 18 Motion, Sonnel proposes interim efforts for submitting the information including: (i) submitting the documents as they became available, and (ii) providing written monthly status reports summarizing progress made, documents obtained, and pending requirements.

Regarding the instructions included in the June 18 Resolution of informal technical meetings with the Energy Bureau's staff and consultants and representatives of the company, Sonnel proposes that they be conducted bi-monthly.

After reviewing the July 18 Motion the Energy Bureau **TAKES NOTICE** of the information provided. The Energy Bureau **GRANTS** Sonnel **until February 4, 2026** to submit the remaining documentation, given that they follow the interim efforts proposed in the July 18 Motion. Furthermore, the Energy Bureau **DETERMINES** that the informal technical meetings will not be subject to a fixed schedule but they'll be planned as circumstances require.
