**MOTION TO REQUEST AN EXTENSION TO COMPLY WITH THE RESOLUTION
AND ORDER FROM JULY 14, 2025**

TO THE HONORABLE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority (“PREPA”), and Genera PR, LLC, (“Genera”) through their counsel of record, and respectfully state and pray as follows:

1. On July 14, 2025, the Puerto Rico Energy Bureau issued a Resolution and Order in the instant proceeding requiring PREPA and Genera to submit monthly reports in Case No. NEPR-MI-2020-0001, beginning on August 15, 2025. These reports must detail: (i) any incidents or limitations arising from the inability to switch fuels in the temporary generation units; (ii) the operational impact of such incidents; (iii) any claims made under the natural gas supply contract; and (iv) supporting documentation, including internal communications and correspondence between the parties to the fuel contract.

2. PREPA and Genera have been in communication to coordinate the preparation of the report. The information necessary to comply with the July 14, 2025 Order resides with Genera, given its operational role in managing the temporary generation units.

3. Genera has informed PREPA that additional time is needed to gather and compile the required documentation. Specifically, Genera has requested until August 22, 2025, to complete and submit the information necessary to comply with the Resolution and Order. PREPA does not object to the extension requested by Genera and joins this request in good faith.

4. Accordingly, PREPA and Genera respectfully submit this motion to notify the Energy Bureau of the ongoing coordination efforts and to request an extension until August 22, 2025, to submit the requested report.

WHEREFORE, for the reasons stated above, PREPA respectfully requests that the Energy Bureau take **NOTICE** of the present Motion and **GRANT** the requested extension.
