RESOLUTION AND ORDER

On July 30, 2025, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("July 30 Resolution") through which, among other things: (i) granted Enernet CHP Two, LLC ("Enernet Two") five (5) business days to submit evidence of payment of the applicable filing fee of its 2025 *Gross Revenue and Financial Statements Report Electric Power Companies* (Form NEPR-B05); and (ii) reminded Enernet Two that if all or part of its system's operation is to be contracted out to another entity, it shall provide the name, contact information, and credentials of the entity or entities to be contracted; and describe what services, equipment, and systems the contracted entity will operate.

On July 30, 2025, Enernet Two filed before the Energy Bureau a document titled *Motion in Compliance with Resolution and Order of July 30, 2025, and Request for Waiver* ("July 30 Motion") requesting, due to the reasons reported in the Motion, that the Energy Bureau waive the payment of the filing fee for the Operational Report pursuant to Section 2.03(B) of Regulation 8701¹.

In the July 30 Motion, Enernet Two did not submit the credentials and information of the contracted entity for the operation of its systems. Previously² Enernet Two reported information about an "Operations and Maintenance Agreement" with certain company to "provide day-to-day operation and maintenance services, including emergency and outages recovery services", and provided the contracted entity contact information but until now it has not provided the full information and credentials of the company as requested in the July 30 Resolution.

Upon reviewing the July 30 Motion filed by Enernet Two, the Energy Bureau **DETERMINES** that Enernet Two **COMPLIED** with Section 2.03(B) of Regulation 8701, setting forth the facts and legal basis why the payment of the filing fee would be onerous, and **WAIVES** the filing fee for its 2025 *Operational Report for Electric Power Companies* (Form NEPR-B03).

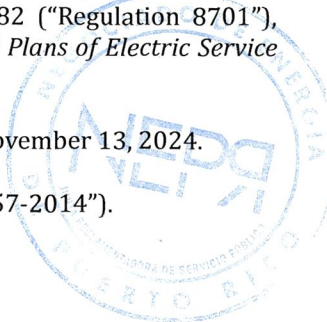
The Energy Bureau **DETERMINES** Enernet Two **DID NOT COMPLY** with the July 30 Resolution, as it did not address nor provide the credentials of the entity or entities to be contracted to operate its system. As such, the Energy Bureau **REITERATES** its July 30 Resolution and **GRANTS** Enernet Two **ten (10) additional days** from the notification of this Resolution and Order to submit such information.

The Energy Bureau **WARNS** Enernet Two that, in accordance with Art. 6.36 of Act 57-2014,³ noncompliance with this Resolution and Order will carry the imposition of fines.




