**MOTION TO REQUEST AN EXTENSION TO COMPLY WITH THE JULY 24, 2025,  
RESOLUTION AND ORDER AND TO NOTIFY APPEARANCE OF LEGAL  
REPRESENTATION**

To the Honorable Puerto Rico Energy Bureau:

**COMES NOW Puerto Rico Telephone Company, Inc. D/B/A CLARO**, through the undersigning counsel, and respectfully states and request the following:

**I. Introduction and discussion.**

1. On July 24, 2025, the Honorable Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order ("July 24 R&O") through which it granted the Puerto Rico Telephone Company, Inc. d/b/a Claro ("Claro") thirty days to submit the information described therein that is related to Claro's June 10, 2024, *Motion to Request Certification as Highly Efficient Generation, to Request Designation as a Personal Microgrid under Regulation No. 9028 and to Request a Determination Regarding the Applicability of Regulation 8701, and to Request Confidential Treatment* ("June 10 Motion").

2. The referenced thirty-day term expires on August 25, 2025.<sup>1</sup>

<sup>1</sup> The thirty-day term expires on August 23, 2025. However, that day is a Saturday and, as such, it is extended to the next business day, Monday, August 25, 2025, pursuant to the provisions of Section 1.09 of Regulation No. 8543, Regulation on Adjudicative, Notice of Noncompliance, Rate Review and Investigations (December 18, 2014).

3. Through the July 24 R&O, the Energy Bureau also authorized members of its staff and consultants to hold informal technical meetings with Claro's representatives and consultants for the purpose of clarifying the requirements set forth therein.

4. Today, the undersigning legal counsel assumed Claro's representation in the instant case. Therefore, Claro hereby respectfully request the Energy Bureau to grant an additional thirty-day term to have an opportunity to meet with the Energy Bureau Staff and representatives to clarify certain aspects of the request for information in order to be able to fully comply with the July 24 R&O.

5. Claro respectfully argues that such extension is reasonable and certifies it is made in good faith and without the intention to unduly delay the proceedings.

## **II. Notice of Appearance and Request for Notice**

1. As stated in Part I of this Motion, the undersigning legal counsel assumed Claro's representation in the instant case. As such he hereby enters a formal appearance as legal counsel of record on behalf of Claro.
